DIRECTIONS TO SIMPSONWOOD

The good news is: you can get there!!!

Directions from I-285:

- Take the Peachtree Industrial Boulevard North Exit (31B). Continue north 3.7 miles to where Highway 141 splits to the left. (Peachtree Industrial Boulevard will go right.)
- Take Highway 141, (the sign will read North to 141 and 400 to Cumming and Dahlonega).
- On Highway 141 (also called Peachtree Parkway), continue north 2.9 miles to East Jones Bridge Road and turn left.
- Continue 1.4 miles to Jones Bridge Circle and turn left. Continue 1.2 miles and turn right into Simpsonwood. Follow the directional signs to the Rollins Center and Registration (approximately 0.6 miles).

Directions from I-85:

- From I-85 southbound: take the Pleasant Hill Road Exit (#104) and turn right.
- From I-85 northbound: take the Pleasant Hill Road Exit (#104) and turn left.
- Continue west on Pleasant Hill Road for 6.1 miles to Highway 141 (Medlock Bridge Road); turn left.
- Go 2.8 miles south to East Jones Bridge Road and turn right. Continue 1.4 miles to Jones Bridge Circle and turn left. Continue 1.2 miles and turn right into Simpsonwood. Follow the directional signs to the Rollins Center and Registration (approxiamately 0.6 miles).

Directions from GA 400:

- From GA 400 northbound: take the Holcomb Bridge Road Eastbound Exit (#7A) and continue 5.5 miles east to Spalding Drive and turn left.
- From GA 400 southbound: take the Holcomb Bridge Road Exit (#7) and turn left. Continue 5.5 miles east to Spalding Drive and turn left.
- Continue 1.2 miles to peachtree Corners Circle & turn left. Continue 0.9 miles to West Jones Bridge Road. Continue 0.6 miles to Jones Bridge Circe, turn left.
- Continue 0.2 miles to Jones Bridge Circle and veer left to remain on Jones Bridge Circle. Continue 0.5 miles and turn left to Simpsonwood Conference Center. Follow the directional signs to the Rollins Center and Registration (approximately 0.6 miles).
