Changes in Accreditation in 2010

REVIEW REQUESTS AND FACE SHEETS:

Centers will now use one "Accreditation Review Request and Face Sheet" for all ACPE Commission reviews with the exception of the annual report.

CHECKLISTS:

The checklists from the 2005 Manual will remain as guides. Two additional checklists will be in the 2010 Manual: 1) Addition of Satellite Program, and 2) Addition of a Program of Supervisory CPE.

SITE REVIEWS:

Ten year reviews will be conducted by "national site teams." The Chairperson of the Site Team will have received specialized training by the ACPE Accreditation Commission, and will be assigned by the Chair of the ACPE Commission. Other members of the site team will be assigned by the regional committees. The Site Team Report will be filed with the Accreditation Commission, and it will not have a regional review. The Chair of the ACPE Commission will assign a "national reviewer" to bring those recommendations to the Commission for action.

APPENDICES:

The number of appendices in the 2010 Manual has been reduced from 10 to 9. Appendix 19 has been changed to Appendix 5, Parts I and II. Herein are described the Standards that are expected to be addressed in the Student Handbook and Curriculum (Part I) and those that are expected to be addressed during the on-site visit (Part II). The intent and hope of these revisions is that Centers can now demonstrate how their handbook and practice are in compliance with the Standards.

NOTATIONS:

The processes for removal of notations and for called reviews have been clarified.

"INACTIVE STATUS":

Because a number of centers are having difficulty filling supervisory positions, too many centers are voluntarily withdrawing their accredited status. The ACPE Commission has instituted an "Inactive Status" for such centers, and this new category, a check list for this request, and the process for reactivation of full accredited member status are included in the 2010 Manual
