Meeting of the Administrative Board, S.E.Region, ACPE

Our Administrative Board met at Hickory Knob State Park on March 6, 2011. Chairperson James Taylor called us to order, and we had good discussions about happenings within the ACPE, Inc. with Bill Baugh, our representative on the ACPE Board of Reps.

We received a report from the Annual Conference Committee regarding our continuing education program being planned for the fall meeting at the Hyatt Regency in Greenville, SC. We received financial reports for the year ending 31 Dec 2010 and the months ending 28 Feb 2011.

We established the reimbursement for standing committee members expenses to be the same as in 2010 (i.e., \$.50 per mile or airfare whichever is cheaper, the cost of lodging or one half for single occupancy, and actual cost of meals).

We reviewed papers written by Jap Keith, and we instructed that they be posted on the regional website.

We noted the early date for the ACPE Annual Conference in 2012, and we instructed accreditation and certification to make adjustments for their meetings within the bounds of the budgets adopted by the region.

We reaffirmed the job description for the Regional Director, and confirmed his perspective that fund raising was not an expectation of his work for this region.

Actions of the Accreditation Committee at its meeting in Hickory Knob

Annual Reports from centers in the region were reviewed.

Program changes noted were:

- The Partnership for CPE: Morton Plant Mease Health Care and Suncoast Hospice: remove Ray Otto and add **Miguel Santamaria** as an ACPE Associate Supervisor.
- Change the name to **CSRA CPE Program at Charlie Norwood VAMC**.
- Add **Nang Ling Lung** as an ACPE Associate Supervisor and remove Dick Tibbits as an ACPE Supervisor.
- Delete **Jacqueline Kelly** as the ACPE Supervisor, and add **Taliferro Williamson** and **Charles F. Pieplow** as ACPE Supervisors at Ingalls Center of Pastoral Ministries in Birmingham, AL.
- Add **Rev. Dr. Cecelia Walker** as the ACPE Supervisor of the Morning Pilgrim Baptist Church CPE Program.
- Add contract ACPE Supervisor **James Gabriel Clark** to the staff at North Atlanta CPE Program.
- Add contract ACPE Associate Supervisor **Brenda Wallace** to the staff at St. Francis Hospital in Columbus, GA.
- Add **Carol Reynolds Green** as the ACPE Supervisor at the University of Alabama Hospital.
- Delete Associate Supervisor **Brenda Wallace** from the VISN 8 CPE Program at James A. Haley Veterans' Hospital in Tampa.
- Note that Vitas has added component site for CPE programs at Cincinnati/Dayton and has deleted component site at Fort Worth, TX.
- Made a recommendation to the ACPE Accreditation Commission regarding Northeast Georgia Medical Center's request to become a candidacy center.
- Made a recommendation to the ACPE Accreditation Commission regarding Covenant Counseling Center's five year review.
- Worked on an educational program for the fall meeting around preparing for a ten year review.
- Began planning the committee's work for 2012. Six centers are scheduled for a ten year review:
 - Baptist Health (Pensacola)
 - Department of Veterans Affairs Medical Center at Memphis
 - Johnson City Medical Center
 - Spartanburg Regional Medical Center
 - Tampa General Hospital
 - Vitas: Innovative Hospice Care
- Three centers will have a five year review:
 - Atlanta VA Medical Center
 - St. Thomas/Nashville CPE Partnership
 - Tennessee Valley Health Care System
 - possibly two more satellites will request accredited member status.

Chairperson Wayne Maberry reports his willingness to resource centers that have received notations in order to assist their compliance with standards.
