Summary of the Treasurer's Report

As of May 30, 2011 the region has received 38% of its projected income (\$53,850). We have expended 34% of the Standing Committees projected expenses (\$17,129) and 34% of the regional office projected expense (\$27,778). Income over expenses on May 30 was \$2,287. It is a good report for this time of the year.

ACPE Executive Director Search Committee

Sally Schwab, ACPE President, announced her appointment of the following persons to serve as the search committee: Mark Jensen, Chair (Mid-Atlantic Region), Nancy Anderson (Eastern Region), Marla Coulter-McDonald (Eastern Region), William Delong (North Central Region), Sally Schwab (South Central Region) and Sandy Yarlott (Pacific Region).

"The Search Committee is charged with developing a profile and process for identifying candidates ready to help lead ACPE in the next chapter of our life and mission. The committee will begin organizing themselves in dialogue with the Board in early summer. Their work will be complete when they have recommended a candidate to the ACPE Board for employment. When a profile and process have been established, they will notify the membership about the way to route applications and/or recommendations."

Letter from Leadership of the Foundation for CPE

A letter from Greg Stoddard, Stu Plummer and Dennis Kenny addressed to the RD of the Southeast Region was received on May 29. The formal phases of the \$15m Capital Campaign for ACPE has begun. To date \$1,014,255 has been received. The stated purpose of the letter was ***"to ask regions to join us in this effort by creating a 3-4 member committee to connect with the Capital Campaign Committee."...*** ***"What we ask of you now is to provide us with the names of your regional committee so that we can begin communicating with them by June 1st. If you need more time let us know."***

This regional committee will "share news on the campaign in the region and give feedback to the Capital Campaign Committee; give feedback to the case statement and information sheets being prepared; identify potential donors (individuals and foundations) in the region; be willing to be trained to communicate with donors if needed and make initial contact with them on this campaign; accompany members of the National Campaign Committee on visits to donors to help tell the "story."

Please consider this request seriously, and let Jim Taylor know of your willingness to serve. By virtue of office, Jim will appoint these four persons to serve on the Southeast Regional sub-committee of the FCPE Capital Campaign Committee. Jim's email address is James.R.Taylor@va.gov.
